The Total Resource Campaign

The Tipton County Chamber of Commerce engaged in a Total Resource Campaign that helped to redevelop all of the Tipton County Chamber's sponsorship opportunities and increased its non-dues revenue.

Before this effort, the sponsorships of the Tipton County Chamber of Commerce largely went untouched for a decade and the sponsorship values had diminished quite significantly. It was because of that diminished value that the Tipton County Chamber engaged in the Total Resource Campaign (TRC). Prior to this TRC, the Tipton County Chamber only possessed three (3) non-dues revenue events throughout the year and those three events generated roughly \$20,000 in non-dues revenue.

After redeveloping our sponsorship opportunities and adding new programs, our Chamber was able to create 15 non-dues revenue programs, with nearly 100 sponsorship opportunities. The Tipton County Chamber set a goal of \$50,000 in its first year with the TRC. Our staff and volunteers were successful in raising over \$52,000, resulting in an increase of over \$30,000 in non-dues revenue. Furthermore, this TRC style of campaign allowed the Tipton County Chamber to increase its number of sponsoring businesses from 22 to 37 and raised the entirety of these funds in a 4-week period.

This success in increasing our non-dues revenue helped our organization hire its second employee and will enable our organization to continue innovating for our businesses and community.
